The Berks County Housing Authority has been designated as the manager for this development by the owner, Tarsus Manor, Inc.

Applicants will be scheduled for completion of a full application to determine eligibility for admission. They will be selected in the chronological order in which their pre-application was received by the Berks County Housing Authority.
